Dear David

Y Fron 2019 Dog Show held at Fron

Please accept our abject apologies for not consulting with the Community Council to request permission to use the field for a 'Dog Show'. I have no excuses and cannot explain why you were not approached, except for an obvious lapse in our organisational responsibilities.

Although the bulk of the organising was undertaken by people experienced in this type of event, it was hosted by Canolfan y Fron and we take full responsibility for our omission.

The organisers and dog owners were scrupulous in clearing up any dog mess during the event and the field was thoroughly inspected after the event to ensure nothing remained.

Please be assured that, in the future, the field will not be used for any event or activity organised by Canolfan y Fron without first consulting with the Community Council to seek appropriate permissions.

Upon investigation it would appear that the 'No Dogs' notice was removed at least several weeks before the dog show, if not longer.

I have spoken to several people who regularly uses the route past the field entrance, and to one lady dog owner in particular, who confirmed the notice had been "gone for a while and well before the dog show". It would also seem that most dog owners in the village 'blame' the Canolfan for trying to keep dogs out of the field and are not enamoured by our assumed actions.

It is true that, over the years, there have been dogs in the field with their owners which, on occasions, I have observed and have, I must admit, not given it another thought.

None of this excuses our lapse in our responsibilities and we ask that the Community Council will accept our apology and look kindly upon us for future events.

12 **RAF Fali / RAF Valley.**

Derbyniwyd gwahoddiad i ymweld y safle gan fod yr RAF yn awyddus i esbonio pam fod yr awyrennau yn hedfan dros y gymuned.

Invitation by RAF Valley to visit as the "Texan T1" aircraft are in operation for our community. The RAF was keen for the community to appreciate and understand why the training was needed, to meet with staff and to answer any questions that arose.

Adroddiad Y Rheolwr

Ymweliad ag RAF Fali 27 Awst 2019

Derbyniwyd gwahoddiad i ymweld âg RAF Fali gan fod yr awyrennau "Texan T1" ar waith dros ein cymuned. Roedd yr RAF yn awyddus i'r gymuned werthfawrogi a deall pam fod angen yr hyfforddiant, i gyfarfod â'r staff ac i ateb unrhyw gwestiynau oedd yn codi.

Eglurwyd fod RAF Fali yn gartref i "No 4 Flying Training School" sydd yn gyfrifol am hyfforddi peilotiaid awyrennau ymladd - sef jets sydyn y dyfodol. Mae'r safle hefyd yn cynnal y Gwasanaeth Tîm Achub Mynydd, yn ogystal â'r "202 Squadron of the Defence Helicopter Flying School". Mae 1,500 o staff yn gweithio yn RAF Fali.

Mae tri math o awyren yn y Fali sef:

1 - Hawk TMk2 - yn darparu hyfforddiant i'r RAF ac i'r Llynges Frenhinol. Jet sydyn yn darparu peilotiaid ar gyfer gwasanaeth yn y rheng flaen. Awyren a ganddi offer modern a soffistigedig.

Erbyn hyn, RAF Valley yw unig ganolfan hyfforddi jetiau cyflym yr RAF yn y DU. Mae pob peilot jet cyflym yn pasio trwodd yma, ac ers cau canolfannau eraill yn Lloegr, byddant yn parhau â'u hyfforddiant o'r Hawk T.1s di-arfog ac uchel ac ymlaen i'r T.1As llwyd a brwydro yn erbyn yn llawn. Gall y rhain gario taflegrau Sidewinder, codennau gwn a bomiau haearn.

2 - Jupiter HTMk1 - hofrennydd modern gydag "Advanced rotary wing". Yn cynnwys y dechnoleg ddiweddaraf sef yr "Airbus Helicopters avionics"

3 - Texan TMk1 - awyren newydd o America - cynhyrchwyd gan Textron Aviation. Mae 10 o'r awyrennau hyn yn y Fali yn darparu hyfforddiant sylfaenol i'r RAF ac i'r Llynges ers 2019. Bydd 4 awyren arall yn cyrraedd y Fali yn fuan.

Fe gyrhaeddodd y Texan TMk1 yn y Fali yn ôl yn Chwefror 2019. Mae'r peilotiaid profiadol yno yn eu hedfan dros yn ein cymunedau yn ddyddiol rhwng 10 y bore a 2 y prynhawn er mwyn dod i arfer â'r awyren. Ym Medi 2019, bydd oddeutu 30 o hyfforddeion yn dechrau eu hyfforddiant yn y Fali ar yr awyrennau hyn. Mae hyn yn golygu fod siawns i nifer hediadau dros ein cymunedau gynyddu yn ystod eu hyfforddiant. Mae rhai aelodau o'r gymuned wedi cwyno am sŵn y Texan. Rhoddwyd gwybod y bydd rhai o'r ymarferion yn digwydd dros Môr Iwerddon yn y dyfodol, fod yna ardaloedd lle nad oes hawl cynnal ymarferion, ond eglurwyd bod ymarferion hyfforddi yn hanfodol er mwyn amddiffyn y wlad.

Manager's Report

Visit to RAF Valley 27 August 2019

We were invited to visit RAF Valley as the "Texan T1" aircraft are in operation for our community. The RAF was keen for the community to appreciate and understand why the training was needed, to meet with staff and to answer any questions that arose.

It was explained that RAF Valley is home to No 4 Flying Training School which is responsible for training fighter aircraft pilots - the fast jets of the future. The site also hosts the Mountain Rescue Team Service, as well as the "202 Squadron of the Defense Helicopter Flying School". There are 1,500 staff working at RAF Valley.

There are three types of aircraft in Valley:

1 - Hawk TMk2 - provides training for the RAF and the Royal Navy. Sudden jet providing pilots for frontline service. An aircraft equipped with modern and sophisticated equipment.

2 - Jupiter HTMk1 - a modern helicopter with Advanced rotary wing. Featuring the latest technology called the "Airbus Helicopters avionics"

3 - Texan TMk1 - a new American aircraft - produced by Textron Aviation. 10 of these aircraft in Valley have been providing basic training to the RAF and the Navy since 2019. A further 4 aircraft will soon arrive in Valley.

The Texan TMk1 arrived in Valley back in February 2019. The experienced pilots are flying it in our communities daily in the morning around 10am and in the afternoon around 2pm to get used to the aircraft. In September 2019, approximately 30 trainees will begin their training in Valley on these aircraft. The number of flights over our communities is likely to increase during their training.

Some members of the community have complained about the noise of the Texan. RAF Valley's response was that some of the exercises will take place over the Irish Sea in the future and that the training exercise

is prohibited in some areas. It was also explained that training exercises were essential to protect the country.
